**AND** 

ST PETER'S CATHOLIC VOLUNTARY ACADEMY TRUST

AMENDING THE MASTER FUNDING AGREEMENT

### **BACKGROUND**

- (A) The Secretary of State for Education and St Peter's Catholic Voluntary Academy Trust a charitable company incorporated in England and Wales with registered company number 7739194 "Academy Trust" entered into a Master Funding Agreement on 1 September 2011 ("the Master Funding Agreement").
- (B) The Secretary of State and the Academy Trust have agreed to amend the Master Funding Agreement in the manner set out in Clause 2a) of this Deed.

#### **OPERATIVE PART**

### 1) INTERPRETATION

Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Master Funding Agreement.

# 2) VARIATION OF THE MASTER FUNDING AGREEMENT

- a) With effect from the date of execution (signature) of this Deed the Secretary of State and the Academy Trust agree that clauses 19 and 20 of the Master Funding Agreement shall be replaced with the following:
  - 19) Subject to clause 20, the Academy Trust shall, in accordance with any guidance which the Secretary of State may issue on the qualifications of teaching and other staff in Academies, employ anyone it deems is suitably qualified or is otherwise eligible under a contract of employment or for services to carry out planning and preparing lessons and courses for pupils, delivering lessons to pupils, assessing the development, progress and attainment of pupils, and reporting on the development, progress and attainment of pupils.
  - 20) Clause 20 does not apply to anyone who:
  - a) is appointed as the SENCO by the Academy Trust under section 317(3A) of the Education Act 1996, who must meet the requirements set out in Regulation 3 of the Education (Special Educational Needs Co-ordinators) (England) Regulations 2008 (SI 2008/2945); or
  - b) is appointed as a designated teacher for looked after children further to clause 18.'
- b) Except as varied by this Deed, the Master Funding Agreement shall remain in full force and effect.

### 3) **COUNTERPARTS**

This Deed may be executed in any number of counterparts (but shall not be effective until each party has executed at least one counterpart), each of which, when executed, shall be an original and which together shall have the same effect as if each party had executed the same document.

### 4) GOVERNING LAW AND JURISDICTION

- a) This Deed and any dispute or claim arising out of or in connection with it or its subject matter shall be governed by and construed in accordance with the law of England and Wales.
- b) The parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter.

This document has been executed as a deed and is delivered and takes effect on the date stated at the beginning of it.
